"Heterogeneity in MNEs' (re-)actions to political risks"

Background

Current international political events underline the importance of proper risk management for multinational corporations. Recently, increasing fear has emerged about a potential military conflict between China and Taiwan. For corporations, it's actually impossible to predict what might happen in case such a potential conflict materializes since today's world and economies are highly interconnected. As such, companies often want to prepare for those events, e.g., by making new location choices. While, for instance, the British pharma company AstraZeneca planned to spin off its China business, other companies decided to even increase their business activity in the currently second-largest economy in the world. This thesis seeks to examine how publicly listed German MNEs differ in their (re-)actions they undertake considering political risks, whereas the emphasis particularly lies on global or regional (geo-)political events. By thoroughly juxtaposing the different paths companies take with respect to internationalization in a certain industry, the thesis provides insights into how these companies make use of portfolio changes to safeguard against political risks and eventually sustain in a rapidly evolving global landscape.
