# "Network Effects on Internationalization Speed of Emerging Economy Multinational Enterprises (EEMNEs)"

## **Background**

In regard to the influence of network ties on internationalization, studies found that EEMNEs, to a large extent, benefit from the political networks at home (Li et al., 2018), strategic linkages abroad (Satta, Parola and Persico, 2014) and domestic networks in their home base (Li et al., 2018) while developing their internationalization strategies. Domestic network created by foreign investments were argued as one of the most important drivers of fast paced internationalization of EEMNEs (Satta, Parola and Persico, 2014). This reinforces the arguments of (Luo and Tung, 2007) that spillovers from inward internationalization, brought in by foreign investors, create an important network advantage for the EEMNEs in their pre-internationalization stage thus helping them immensely in their internationalization phase.
